# To approve the Clerk's recommendation to use the payroll service provider, One Less Worry

Quoted Payroll fees = £25.00 x 12 = £300.00

A new budget line could be created for professional services but if the Council agrees £300 could be vired from the £2,000 allocated to admin costs in 2021/22.

Amount spent on admin costs up to  $31^{st}$  January 2021 = £1821 This includes a new laptop costing £512.

Admin costs for 2019-20 = £2316

#### Recommendations for using the payroll package

- Save's on Clerk's time
- It could be incorporated within the Council's Risk Management Scheme if the Clerk is unwell / unavailable there would be the contingency that staff will still get paid. (the Chair of the Council or Staffing Committee could act as an additional point of contact.
- Many internal auditors do not recommend that Clerks process their own payroll.
