Describe the overall aim of your organisation and the Aim: a. To promote the accessibility of St Germans and the activities or services it surrounding area by train and bus; provides b. To represent users of St Germans station, and bus users in St Germans and the surrounding area, in discussions with agencies and train and bus operators. We work closely with the Rame Peninsula Public Transport Users Group. We represent passengers in the St Germans, Rame peninsula and Deviock areas in discussions with GWR, Go Cornwall Bus, and local councils - coordinating with Rame PPTUG. We produce regular train and bus timetables which are made available in various villages (and also posting some door to door). We deal with a number of questions from individuals about services and experiences on public transport. **ABOUT YOUR PROJECT St Germans & Rame Integrated Public Transport Scheme**

The aims are:

- to examine transport patterns and needs of the local population (by age and locality);
- To examine ways of enabling and encouraging the use of buses and trains
- To explore public perceptions of benefits in future of a connected service between bus, rail, and other services
- To encourage positive messages about public transport use and the environment
- To investigate the information flow between the public, local authorities, local transport agencies and funders

We will conduct a questionnaire survey, in both electronic and paper forms, throughout the Rame peninsula. The completed questionnaires will be analysed and the resulting report provided to local communities via local newspapers, council websites, radio and TV.

Reports will be sent to parish and county councils, community transport agencies and transport providers.

The information from the survey will alert people to the various possibilities of using public transport now and in the future. It will be of use to Cornwall Council, and train and bus operating companies in making decisions about future services. It is hoped that more integrated public transport services will be developed as a result. It is similarly hoped that there will be various improvements at St Germans station, such as facilities for charging electric vehicles, facilities for electric bicycles etc. In addition there could be information from people in parishes about needs they have to travel to a range of places, by bus or train, about the difficulties of reaching places - information which local authorities and transport providers could use in future planning. This is particularly important in the current situation of climate crisis. A major aim of the project is to encourage more use of public transport, of car sharing and cycling etc. This will mean less pollution and less congestion on roads.
